# SAFETY WORKSHOP

#### Safety Card for A.A. Groups

(The General Service Office has made this optional statement available as an A.A. service piece for those groups who wish to use it.)

Suggested Statement on Safety

Our group endeavors to provide a safe meeting

place for all attendees and encourages each person here to contribute to fostering a secure and welcoming environment in which our meetings can take place. As our Traditions remind us, the formation and operation of an A.A. group resides with the group conscience. Therefore, we ask that group members and others refrain from any behavior, which might compromise another person's safety.

Also, please take the precautions you feel are necessary to ensure your own personal safety, for example, walking to your car in a group after a meeting. If a situation should arise where someone feels their safety is in jeopardy, or the situation breaches the laws, the individuals involved should take appropriate action. Calling the proper authorities does not go against any A.A. Traditions and is recommended when someone may have broken the law or endangered the safety of another person.

Service Material from the General Service Office

Our common welfare

Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward. - Tradition One (Long Form)

It is hoped that our common suffering as alcoholics and our common solution in A.A. will transcend most issues and curtail negative behaviors that could jeopardize the safety of anyone attending an A.A. meeting. Nevertheless, Alcoholic Anonymous is a microcosm of the larger society we exist in. As such, problems found in the outside world can also make their way into the rooms of A.A. For this reason, groups and members discuss the topic of safety - to raise awareness in the Fellowship and to seek through sponsorship, workshops and meetings to create as safe an environment as possible to carry A.A.'s message of hope and recovery to the still suffering alcoholic.

The Safety Workshop Panel consisted of Suzie N. from A Spiritual Awakening; Jeremy from Knuckle Heads, Linda T. and TJ, from A "Wake Up Call;" and Deborah S. facilitated the panel discussion. The workshop covered various aspects of Safety in A.A. and below are just a few: Sniper Sharing. I had never heard of this before. Apparently, it is a form of cross-talk at the podium. For example, "If I was someone who…" It is meant to slam someone indirectly, in front of the group. Inappropriate touching: several young women expressed feelings of discomfort when older men let their hands linger too long, too tight or too close to private areas. One lady stated from the podium that she preferred not to be hugged for this specific reason.

This topic was followed up with do we get TRO's against A.A. members, and can we ban someone from A.A.?

*Panel Discussion:* The answer is Yes! We certainly should get a TRO if the behavior warrants that course of action, and No we cannot ban someone from A.A. as a whole. However, each group is autonomous and has the ability to 86 anyone who is endangering its members or damaging the facility where they meet. We listened to various stories from members who experienced predators in A.A. It was highly suggested that men work with men and women work with women. If someone is actively perusing you, asks you "to keep the relationship a secret, or asks to borrow money", they may be attempting to take advantage of the disadvantage (better known as 13 stepping). We encourage you to talk to an elder statesman A.S.A.P. Again, the solution is to ask for help! Possibly have a discussion about Safety in your Homegroup's Business meeting. Come up with a game plan. Ensure that our meetings are safe as possible to carry the A.A. message of hope and recovery to the still suffering alcoholic.

## GOT SERVICE?

I was sitting up on my top bunk in MCCC when I saw three women come walking down the hill towards our dorm. The officer bellowed, "AA in Dorm Five!" And off I went to my very first AA meeting. This was my intro- duction to service, and it had great importance in my life. If these women had not been of service carrying the message of AA into MCCC, I probably would not have remained sober. Service continued to carry me through my journey in my early days in AA, even while I remained incarcerated. I was on an electronic monitor and trying to convince my counselor that meetings were very important. When she remained stubborn, I made myself the "Assistant Coffee Maker" at the Wailuku Group. Now, I doubt the coffee maker needed an assistant, but my new home group encouraged me to help, and I was al- lowed by my counselor to attend the meeting since I held a "Service Position." Being a painfully shy person, this position allowed me to meet people one cup at a time, build a fellowship slowly as well as have a home group. I learned how business meetings worked, and what a group conscience was. I felt part of something, and even though I wasn't really holding a position, I was welcomed as a home group member. My service, in assisting the coffee maker, was respected. My journey upon release from MCCC brought me to Kihei. I was new to Kihei, and at my very first Saturday morning meeting someone nominated me for Secretary in order to welcome the new girl to town. Again, it made me feel "part-of" and included. For other groups I have held many varied service positions. In each position what I have found is that it keeps me present and involved. I have discovered that there are certain positions I am just not cut out for. (God bless those that are.) I recognize my limitations. An old friend used to say he liked to be the spear carrier in the second row. I like that. Suits me just fine. If those three women had not walked down that hill, I would not be sober. Service brought me to AA, so I owe a debt I cannot ever pay back, and I am delighted to do so. Currently, it is my extreme pleasure to be of service as the liaison between AA and MCCC. It is now my turn to make the arrangements for women of AA to carry the message into MCCC. Who would have thought I would be given this opportunity? My favorite form of service? Sponsorship. I love giving back what my sponsor has given me. It's so cool to always be in the literature, meeting with the women I work with, hanging out, talking, laughing, crying, drinking tons of coffee, working the steps and getting to know each other. One alcoholic talking to another. It doesn't get better than that. If you are contemplating going into service and struggling with what type of position may suit you, let me tell you what my sponsor said to me once upon a time. (I was still on the electronic monitor and very limited on mobility.) She told me there were all kinds of service: helping to stack the chairs, giving someone a ride home, putting out your hand to a newcomer, smiling and saying hello, sharing your story so someone can re-late to you, showing up at the same meeting regularly so you become a friendly face, putting a little some- thing in the basket to help the 7th tradition, taking down numbers and calling people to say hello. There are so many ways to start. You can build from there. Next step ... Coffee Maker! If you don't think you can handle it, I highly recommend the position of Assistant Coffee Maker.
